In our time at John Carroll, we have received a good education, yet we think that there is an important element of our education that is missing: diversity in the thinkers and intellectuals that we are reading. Throughout most John Carroll classes, the syllabus is composed completely of Western thinkers that are white and male. As this excludes large amounts of John Carroll students, the Student Union would like to ask professors to include writers in their courses that include at least two minorities within the enumerated identities:

- Gender
- Sexuality
- Race
- Religion
- Socioeconomic class
- Physical and mental ability
- Any other marginalized or underrepresented group

We recognize that in some disciplines this may be easier than others. That is why we only ask you to pick at least two authors from underrepresented groups. We acknowledge the difficulty, but suggest incorporating interesting articles that represent the complexity of your discipline that are written from different perspectives. As a Jesuit institution that advocates social justice and the importance of a well-rounded education, it only makes sense that the curriculum become more diverse. The world is becoming an increasingly globalized and diverse place. The reality is that in many disciplines there has always been diversity, though it has been largely ignored or underrepresented. As these disciplines are starting to have more people from marginalized groups than from the majority, it is important to acknowledge the already present diversity therein.

In order to present students with more than one perspective in their disciplines and their education, we believe it is vital to diversify the curriculum. This will make the classroom a more open place for those who belong to marginalized groups, and help everyone realize that important contributions have been made in all fields by groups that have historically been underrepresented.
