Draft vision statement: "Grounded in its Jesuit Catholic tradition, John Carroll
University will build upon its strengths and innovate to educate a diverse
population of undergraduate, graduate and non-traditional students to become
inspired and discerning learners and leaders in service to others through their
areas of study, with particular distinction in areas that include health sciences,
analytics, business and service learning. In doing this, JCU will be a top-ranked
regional, private university delivering excellent academic programs by an
excellent faculty in an environment where students feel at home."

...and whitepaper about what we mean by "Jesuit Catholic Tradition"

'Deep concern' about lack of citation of liberal arts in the proposed vision statement. 'Deeply disturbing' 'almost offensive'

Deadline for whitepaper? Reported that P. Kvidera has a Feb. deadline in mind Team three working on this statement and having open hearing regarding it

My place is invisible in this statement – How do we write to how we fit within the vision? (e.g. doing the Academic program evaluation process)

Support from business faculty (multiple) – grounding in the liberal arts is key What are 'analytics'? 'health sciences'?

Chairs meeting in CAS discussed this and communicated to Provost

Be true to whom we are. Wondering if it is worth making motion to include 'liberal arts'

Frustrating – feels like things are decided, even though Goal groups are coming up with strategic plans

Is this statement up on the web? Available to public?

If this is 'live' it needs to come down

Here's who we are and here's why it is important/attractive.

How do we encapsulate why liberal arts is important and make it attractive This draft leaves out 'inspiration' purpose

Creativity and imagination is missing. Statement seems to focus more on numbers.

Motion to remove this draft vision statement from public website until we are clearer on its meaning and the inclusion of the liberal arts M. Peden, 2<sup>nd</sup> by M. Lynn

Purpose of vision statement vs. purpose of a marketing statement?

Since it is a draft statement, it shouldn't be public

Care more about inclusion of 'liberal arts'

Would rather write APE's to Mission statement
